

Queries submitted by prospective bidders on ITB No.: UNFPA/NPL/18/001 “Manufacture and/or supply of dignity kits and kishori kits”

Question: Incoterm: CPT Nepal - what is the address for delivery in Nepal?

Question: What is the quantity of each kit?

Answer: We are looking forward to have an LTA valid for three years and hence, our requirement is that we look forward for supplier or manufacturer who has the capacity to deliver at least 5000 units of the kits within 7 days from the date of order.

Question: What is the correct deadline for samples? Page 1 shows deadline as 5th April. Page 15 shows deadline as 2nd April.

Answer: The deadline for submission of samples is 5th April 2018, 1500 hours Nepali Time.

Question: Can we send 1 piece of each item instead of the entire kit?

Answer: Yes. Samples of each items listed under Section 2.2, Technical Specifications are to be submitted.

Question: Also... some items are the same for both kits. Hence can we send only 1 piece for such items.

Answer: Please refer to above answer.

Question: At least five sets of Dignity Kits should be packaged into single nylon sack. Could you share pictures for reference?

Answer: This should be an ordinary nylon sack that can fit five sets of Dignity Kits.

Question: Does the same kitting have to be followed for the Kishori Kits as well (5sets in a nylon sack)

Answer: Yes.

Question: Do the nylon sacks have to be further packed into cartons?

Answer: No.


Question: Flashlight: There are specs for 2 types of flashlights. Please confirm if either one OR both are required in each kit. (For both the Kishori and Dignity kit).

Answer: Please be informed that the samples of both types are required along with the price quotation. However, both kits will contain only one from either option.

Question: What is the GSM for Towel / Gamcha. Towel and Gamcha are two different items – can you kindly therefore share a picture of the item you need?

Answer: Cotton Gamcha not less than 240 GSM.

Question: In Kishori Kits you need a pouch. What is this pouch for? Given the size of the pouch ... the kit items will not fit in this pouch?



Answer: Only few items will be packed in a pouch, hence the pouch size is fine.

Question: If the kishori kit is not to be packed in the pouch, then how is it to be packed?


Answer: The given sized pouch is to be used to pack kishori kit

Question: Item 9 flash light: The tender document is mentioning item 9a and 9b. Please confirm either 9a or 9b should be included in the kit (not both of them). Also seeing the fact that self-powered flash light is a more expensive option, can you please let me know what would have the preference during the tender evaluation? The price or the type of product?

Answer: Only one type of flashlight will be kitted in the kit. The evaluation will be carried out on the basis of both technical and financial aspects.

Question: We would like to ask whether the deadline for the submission of the samples and quotation can be extended with 2 weeks. The reason we are requesting the extension is the fact that the transit time for the submission of the samples by a courier is 5 days for us. To be sure we can meet de deadline we need to calculate 7 working days. As we believe we can provide you with a competitive quotation I hope the extension can be possibly granted.

Answer: We cannot extend the deadline for submission of samples. We have given 4 weeks time to plan and submit the bid.
